# Pittsburgh International Airport (PIT)

The hotel is about 30 minutes from the airport. For more information about air service to Pittsburgh, arrival times and terminal information, please visit the airport website before embarking on your trip.

### Taxis

Travelers should only use taxi service when van service or rideshare is not available or if the cost of sharing a cab with another attendee is comparable to the shuttle fare. Taxicab service is in Landside Terminal, through baggage claim near door #4. Expect to spend \$130 for a one-way trip and possibly more if traveling early morning or late evening.

#### Rideshare

Rideshare (Uber/Lyft) pickups occur in Landside Terminal. Passengers will proceed through baggage claim for access to door #4 for ground transportation. Expect to spend \$40–50 dollars for a one-way trip and possibly more if traveling early in the morning or late in the evening.

### **Public Transportation**

Pittsburgh Regional Transit offers public transit service to and from Pittsburgh International Airport via the 28X Airport Flyer. The 28X route serves Pittsburgh International Airport, Robinson Towne Center, Downtown Pittsburgh, and Oakland seven days a week.
