

Q12. Are nurse board members required to be currently employed in nursing at time of appointment/election?



Q13. Are nurse board members required to be licensed within the jurisdiction at time of appointment/election?


Q14. Are board members required to reside within the jurisdiction at time of appointment/election?



Q15. Are consumer applicants as board members required to meet specific qualifications to be considered for appointment/election?


Q16. Are consumer board members excluded from participation in selected functions/duties of the Board of Nursing?



Q26. Who appoints/hires the Executive Officer?


Q27. Who has the authority to make internal staff hiring and termination decisions?





Survey Terminology

The following terms are used throughout all surveys:

Board of Nursing: Jurisdiction's governmental agency responsible for the regulation of nursing practice. Includes any other terminology to refer to the regulatory authority (i.e. commission, examiners, registration, jurisdiction). When referring to Board of Nursing, the reference collectively includes Board Members, Executive Officer and Staff.

Jurisdiction: Refers to state, territory or district where a Board of Nursing is located. May also be used to refer generally to the Board of Nursing in a particular jurisdiction.


Board Staff: Staff of the board of nursing

Executive Officer: Person responsible for running the Board of Nursing. Includes any other terminology to refer to that authorized person (i.e. Executive Director)

Board Member: Member of the governing body of the Board of Nursing as outlined by statute





Q37. Does the Board of Nursing draft or approve its budget?



Q40. What percent of the budget is allocated for disciplinary matters?



Q41. What percent of the budget is allocated for licensure (initial and renewals)?


Q5. Are specific advanced practice registered nurse roles mandated for inclusion as board members?
