

## Overview of NP profession in Canada - History



### Overview of NP profession in Canada – Current stats

- 8,000 NPs currently work across the country (2023); with approx. 310,000 RNs
- NPs are licensed as Family All Ages, (older PHC), Adult, and Pediatric/Neonatal
- 29 schools across Canada offered one or more NP programs
  - 717 NP graduates in 2021 (CASN)
- Annually numbers grow by about 10% per year
- NPs work across all areas of healthcare, many in primary care or in a community setting (37%), but also in acute or hospital settings (35%)


### Overview of NP profession in Canada – Regulation

- 12 regulatory jurisdictions representing provinces and territories
- NPs regulated by provincial or territorial legislation
- Canadian Council Registered Nurse Regulators (CCRNR)
  - committed to safe nursing across Canada and working together toward consistency and harmonization in nursing regulation for the Canadian public
  - establish liaisons and partnerships that best position CCRNR and its members to address registered nurse regulatory matters
  - promotes an understanding of the purpose of nursing regulation and members' commitment to public safety and excellence in regulation

### Overview of NP profession in Canada - Regulation

- Regulatory challenges with NP practice
  - Limited diversity of NP roles and skills to meet evolving population needs
  - Smaller number of NPs in some categories
  - Difficulty maintaining category-specific education programs
  - Lack of robust, reliable, and valid exam for all categories of practice
  - Limits to labor mobility across the country

#### New NP Regulatory Model

- Impetus for a new model
  - 2015 Practice analysis
  - Set the stage for a national conversation for a new model

#### New NP Regulatory Model

- Nurse Practitioner Regulation Framework Implementation Plan (NPR-FIPP)
- NPs across Canada will:
  - be educated based on common NP entry-level competencies (NP ELCs)
  - take a common NP entry-level registration exam, and
  - be ready to provide care across the life span in all practice settings as beginning practitioners
  - use one consistent protected title

#### New NP Regulatory Model


- Enable the appropriate level of NP regulation in the public's interest
- Regulators:
  - will no longer regulate different categories of NP practice
  - will require NPs to practice within their individual competence and regulated scope of practice
- NPs will continue to develop knowledge and expertise over time and, if desired, additional, voluntary, postentry-to-practice specialization
- Foster a more mobile and responsive NP workforce

#### NP Project Deliverables

- National Entry-Level Competencies for NPs (NP ELCs)

- One NP entry level registration exam by 2026
- Legacy planning



#### Legacy Planning

- NPR-FIPP working group to determine legacy plan
  - Possible two legacy plan options
  - Possible attestation when changing category/stream of practice
- Challenge to determine how the new model will impact currently licensed NPs
  - Causing current NPs to be uncomfortable
